Guidance notes

Applications

The fund is open to applications from community organisations, or individuals applying for funding for community purposes, located within the Parish of Braemar.

The Application Deadline will be advertised in advance in local media.

Applications should be submitted to the Secretary on the Application Form, who will acknowledge receipt. In some circumstances the Panel may ask for further information.

Applications can be for any amount up to 50% of the funds available. Funds available for 2021 are £20,000 meaning that the limit for any one application is £10,000. In general it is preferable for applicants to source funds from more than one source, especially for larger projects.

Meeting Procedure and Frequency

The Panel will normally meet in private but may occasionally request applicants to attend.

Awards may meet applications in full, in part, or not at all.

Awards will consider which applications have the greatest and widest benefit to the community of Braemar and will do so with consideration both to the fund balance, the number of applicants, and to any previous awards.

There is no right of appeal but applicants can reapply even if they have been unsuccessful in the past.

The fund is expected to be topped up annually based on performance of the Hydro scheme.

In exceptional circumstances (e.g. disaster relief) the Panel may consider applications or make funding grants outside the normal meeting cycle, beyond the parish boundary, or above the application limit.

Applicant Responsibilities

Applications can supply back up information if they feel that is helpful; e.g. to substantiate major cost estimates.

Applicants are responsible for reporting on the use of funds and returning any funds unused within 12 months of the award. The Panel may ask for evidence of how funds were spent.

Panel Members

The Funding Panel comprises five representatives. The current Panel comprises David Geddes, Liz Robertson, Sam Tait, Rhi Turner and Molly McIntosh.

This Panel was nominated by Braemar Royal Highland Society, Braemar Community Hydro, Braemar Community Council, Braemar Community Limited and includes a youth representative.

Panel members will use their judgement to make awards in the best interests of Braemar.
